## U.S. Citizen/Eligible Non-Citizen Authentication of Documentation

Students may verify their U.S. citizenship/eligible non-citizenship status by either appearing in person at The HUB or providing notarized authentication of their document. If appearing in person, you will provide your identification, and a university-designated staff member will review your identification document for approval.

If you are unable to appear in-person, you will need to have this form completed by a notary (see notary section) and provide a copy of the identification used. Once you have the notarized form and copy of your identification, you may submit these items through one of the following methods: the My Student Aid portal, email to <a href="mailto:thehub@andrew.cmu.edu">thehub@andrew.cmu.edu</a> or by mail (at the address listed above).

Examples of documentation that may be used to verify U.S. citizenship/eligible non-citizenship status are a U.S. passport, Birth Certificate, Certificate of Naturalization, Permanent Resident Card, or Resident Alien Card.
