International Student Information Form – Pre-College 2012

As an enrolling student, you must provide verification of financial support to obtain an **I-20 Certificate of Eligibility**.

You will then use the **I-20** to obtain a U.S. entry visa, F-1 status.

Please follow the instructions carefully. When all required forms and documents are received and reviewed, the I-20 will be processed and sent to you as directed below. You should allow three weeks processing time.

NOTE: Forms submitted by email or fax will not be processed. Incomplete forms or those with insufficient funds will not be processed.

INSTRUCTIONS:

- **READ** and answer all questions on this form.
- **SUBMIT** all of the following as one complete package:
 - 1) **International Student Information Form**
 - 2) **Photocopy of the picture page of your passport** to verify your date of birth and the spelling of your name.
 - 3) **Affidavit of Support for Financial Sponsor**
 - 4) **Supporting financial documents** from yourself and/or each family member or other individual who will contribute money to finance this Pre-College program.

Supporting financial documents must be: **1)** in English, **2)** original documentation (no copies, faxes or scans), **3)** dated less than 6 months old, and **4)** clearly state the name of the account holder and the available balance in U.S. dollar value. Foreign currency will be converted upon review of this file if necessary.
