**\$50** - *Outside Musician Fee* (if you choose to use an additional instrumentalist or vocalist, which requires extra rehearsal time, this fee applies)

**\$50** - *Rehearsal Fee* (if you require that Artist attends the wedding rehearsal, this fee applies)
