Examples of prizes/awards include classroom competition, prize rewarding outstanding performance, random door prizes, survey participant or recognition of achievement.

Do not use this form if the prize/award is for an employee and student employee. Complete an Activity Pay and One Time Payment Form [.pdf] for current employees to provide a cash prize/award or complete an Employee Gift Processing Form [.pdf] to provide a noncash prize/award or gift card.

Note: A copy of prize/award documentation must be attached to this form, otherwise it will not be processed. ALL PAYMENTS WILL BE SENT DIRECTLY TO THE RECIPIENT. CMU will issue the recipient's payment via Electronic Funds Transfer (EFT). The recipient must provide their banking information by submitting a completed Accounts Payable Supplier Electronic Funds Transfer Form [.pdf].
