12 p.m. (noon) on December 19, 2023—All students who submitted cancellation requests (even if they haven't yet been verified/ approved) must completely vacate their room/apartment.

12 p.m. (noon) on December 19, 2023—Deadline for remaining roommates to request a pull-in (new roommate), and also the deadline for those pull-ins to completely move into the space they are being pulled into (pull-ins MUST move before they leave for Winter Break)

48 hours after approval—Full refund of Spring 2024 housing charges should be posted to your student account and cancellation fee applied
