Definitions:

Alumni: Defined as (a) all persons who have been admitted to any school or college of Carnegie Institute of Technology or Carnegie Mellon University, who have completed at least one semester of classes in a degree program, and who have left the University in good standing and (b) all persons who have received an Honorary Degree from the University.

Active: Defined as all alumni who maintain a current postal or e-mail address

E-mail Only: Indicates that the only contact information available is e-mail address

Alumni Interest Group: Any group of Carnegie Mellon alumni who share a common interest or bond and who desire to affiliate with each other as a subgroup of the Carnegie Mellon Alumni Association. Alumni Interest Groups are formed around at least one of the following criteria:

Former membership in an officially recognized student organization
A shared personal characteristic (such as ethnicity, cultural background, or religion)
A shared postgraduate professional experience (such as entrepreneurs, lawyers, doctors, etc.)

Chapter: Historically, "clan" was chosen to describe the regional alumni groups of the Carnegie Mellon Alumni Association, reflecting the Scottish heritage of Andrew Carnegie. In recent years, "chapter" is used with more frequency as new groups are formed. For ease of reference, "chapter" refers to both clans and chapters.

Honorary Alumni:

For degree level, honorary alumni are counted within the "Non-Grad/Certificate" category For degree college and preferred degree level, honorary alumni are within the "Other/Honorary" category

Annual Giving

In addition to engaging alumni as volunteers, event participants, and CMU ambassadors, the Office of Alumni Relations and Annual Giving strives to increase annual financial support from all Carnegie Mellon constituents, including alumni, parents, faculty, staff, friends, and students. We seek both unrestricted gifts to the Carnegie Mellon Fund (which support "the university's most pressing needs," as determined by the administration) and restricted gifts to a variety of campus departments and programs.

Alumni Association Board

Twenty-three Voting Members:

Twenty Directors – five elected each year for non-renewable four-year terms

Three Officers serving two-year terms each – President, Immediate Past President, and President-Elect

Three to four Ex-officio Members – VP for University Advancement, Associate VP of Alumni Relations and Annual Giving, a student representative from the Highland Ambassadors, and a rotating representative from the Andrew Carnegie Society Executive Board

Alumni Interest Groups

Alumni Interest Groups are formed around at least one of the following criteria:

Former membership in an officially recognized student organization (past or present)

A shared personal characteristic (such as ethnicity, cultural background, or religion)

A shared postgraduate professional experience (such as entrepreneurs, lawyers, doctors, etc.)

Awards and Recognition

The Carnegie Mellon Alumni Association presents annual awards to recognize alumni achievements, and to recognize alumni, student and faculty service.

Chapters

Fifty-two active domestic chapters (30 Central and 22 Tepper School of Business)

Thirty-two international chapters (19 Central and 13 Tepper School of Business)

Online Services

Carnegie Mellon provides online services for alumni and students at http://www.cmu.edu/alumni, including an online directory, e-mail forwarding, event calendars and registration, online giving, social media presence, and regional and alumni interest networks web pages.

Reunions

Class reunions are celebrated in decades during Spring Carnival and Reunion Weekend; however, the 50th reunion class and the platinum class (those beyond 50 years) celebrate during Cèilidh Weekend in the fall. The reunion classes serve as the hosts for the event.

Student Programs

The Alumni Association sponsors several programs including, Dinner with 12 Tartans, Real Life Story Series, Student Cèilidh Committee, First-year Student Alumni Association Welcome, Student-alumni social events, and programs during Orientation and Commencement. We also select students to represent Carnegie Mellon University as members of the Highland Ambassador program.

Carnegie Mellon Alumni Travel Program

Up to six educational travel programs are offered each year for Carnegie Mellon alumni and friends of the University.




