I understand that in order to promote CMU and its programs, including promoting the Program to the CMU community, the Program may ask participants to provide photographs of themselves and/or arrange for photographs to be taken of participants while participating in the Program. I hereby grant to CMU and its licensees and each of their respective successors and assigns a world-wide, perpetual, royalty–free, non-exclusive, irrevocable right and license to publish, display, reproduce, distribute, telecast and otherwise use my name, likeness, and any photograph of me taken on behalf of CMU or provided by me to CMU at the request of the Program in any manner and medium to promote the University and/or its programs, including promoting the Program to the CMU community.
